Attachment n. 1 – Study plans

Art. 1 – Denomination, class, place and duration

- 1. The Master's degree program in Economic Development and International Relations, activated by the University of Pavia's Department of Political and Social Sciences, under LM-52 class of Master's degrees in International Relations, as per the Ministerial Decree n.1649 of 19 December 2023.
- 2. The program duration is two years.

Art. 2 – Reference legislation

- 1. In compliance with freedom of teaching principles and the rights and obligations of teaching staff and students, the didactic organisation and development of the training activities foreseen for the Master's degree course are governed by this text, by the Statute of the University of Pavia, the General University Regulations, the University Didactic Regulations, the Student Career Regulations and the Regulations of the Department of Political and Social Sciences (available at https://portale.unipv.it/it/ateneo/organizzazione/statuto-e-regolamenti and https://scienzepolitichesociali.dip.unipv.it/it/dipartimento/atti-e-documenti/regolamento).
- 2. For that not expressly provided for in these Regulations, current provisions of the law apply.

Art. 3 – Organisation responsible for didactics and organisational co-ordination

- 1. The Master's degree course in Economic Development and International Relations is under the Department of Political and Social Sciences.
- 2. The Department Board will assign, from its permanent staff, a lead teacher who will co-ordinate and organise the course.
- 3. The lead teacher will be assisted in his/her activities by a management group to ensure quality (AQ). The group will also be assigned by the Department Board.

Art. 4 - Reference administration services

- A Department Didactics Office has been set up in order to provide administrative support for the didactic activities of the degree course and which the student can contact regarding problems related to the activities themselves.
- 2. For issues and practices relating to students' career (enrolment, transfers, fees, student mobility, etc.) competence is attributed to the offices UOC Immatricolazioni e Informastudenti, UOC Carriere Studenti, UOC Gestione Amministrativa e Contribuzione Studentesca and UOC Mobilità Internazionale. The Orientation Center (C.OR.) supports students' university career choices and facilitates their entry into the work world. Services offered by COR can be consulted at https://orienta.unipv.it/scegli-unipv.

Art. 5 - Annual Study Programme form

By the deadlines indicated by the Ministry, an Annual Study Programme form (SUA) of the master's degree course is prepared. The form contains all the information relating to the training path provided for the reference cohort and which can be consulted at https://gestionedidattica.unipv.it/index.php/file/2025SUA03410.pdf

Art. 6 – Admission requirements

- 1. To be admitted onto the master's degree course, students must hold a three-year university degree or diploma, or an equivalent qualification obtained abroad that is recognised as suitable by the competent University bodies. Conditional enrolment is permitted for applicants about to obtain a required qualification (which, however, within the deadline established by the Academic Calendar) and who, at the deadline date for submitting applications or for the evaluation of qualifications referred to in paragraph 5, have acquired at least 150 university credits.
 - For enrolment onto the master's degree course, students are also required to hold certain curricular requisites (see clauses 2-4) and be of the required personal profile (see paragraphs 11-12).
- 2. Students holding a degree in one of the following ex-Ministerial Decree class 270/2004 or in the corresponding ex-Ministerial Decree 509/1999-degree classes are admitted directly onto the master's course:
 - L-18 (Economics and Business Management);
 - L-33 (Economics);
 - L-36 (Political Sciences and International Relations);
 - L-37 (Social Sciences for Cooperation, Development and Peace).
 Regarding knowledge of the English language, students who hold at least 6 university credits (ECTS) in scientific sector L-LIN/12 (Languages and translation English) or who have been awarded a degree (or equivalent) in English are admitted directly.

Students who have been awarded a degree (or equivalent) in Italian are directly admitted.

- 3. Students who meet the requirements set out in clause 2 and have acquired at least 150 ECTS by the deadline for applying for admission are also directly admitted.
- 4. Candidates holding a bachelor's degree different from those listed in clause 2 must apply for an evaluation of their qualification in order to verify whether they possess the minimal entry requirements. These consist of:
 - 18 ECTS from the economics-statistics, law and political science areas (of which at least 6 and a maximum of 12 from the economics-statistics area). The scientific disciplinary sectors are:
 - Economics-statistics area: SECS-P/01 (Political Economy); SECS-P/02 (Political Economy); SECS-P/03 (Financial Sciences); SECS-P/06 (Applied Economics); SECS-S/01 (Statistics); SECS-S/03 (Economical Statistics); SECS-S/04 (Demography);
 - Law area: IUS/01 (Private law); IUS/02 (Comparative private law); IUS/05 (Economy law); IUS/08 (Constitutional law); IUS/09 (Public law institutions); IUS/10 (Administrative law); IUS/13 (International law); IUS/14 (European Union law); IUS/21 (Comparative public law),
 - Political Science area: SPS/04 (Political science).
 - Students who do not have 6 ECTS in the disciplinary sector code L-LIN / 12 (Language and Translation English language) or who have not obtained a degree (or equivalent) in English must apply for the assessment of qualifications to verify whether they possess qualifications or certifications equivalent to an English language proficiency level of B2. Students who have not obtained a degree in the Italian language must apply for verification of qualifications or certifications to assess equivalence of their knowledge of the Italian language at level B2.
- 5. Candidates with qualifications awarded outside Italy must also present an evaluation application.

- 6. If the candidate does not hold the required educational credits, the Commission reserves the right to assign a dedicated study programme in order to attain the minimum level of knowledge necessary to enrol on the degree course. This programme consists, in most cases, in the attendance of courses to be purchased by the student as 'single courses' at the universities and in passing the relevant exam before enrolling onto the master's degree. In any case, the Commission reserves the right to evaluate any other qualifications or personalised programmes taken in order to reach the entry requirements.
- 7. Students are assumed to have a B2 level of English. In order to identify any knowledge gaps, students must enrol or apply for the evaluation of qualifications referred to in paragraph 5 after taking the placement test available on the Kiro online platform (https://elearning.unipv.it/login/index.php?lang=en). Students must print the screenshot showing their test score and present this document for the evaluation of the qualifications referred to in paragraph 4. The test will make it possible to identify a study programme that will enable students to meet the conditions for access to the course outlined above.
- 8. The Commission, nominated by the Department Director, will evaluate if students possess the course entry requirements illustrated in paragraph 4.
- 9. The Commission evaluates whether students possess the above- mentioned requirements through a check of qualifications based on the documentation provided by them in order to certify candidates' academic career and the result of the test referred to in paragraph 7. In the event that, during the assessment of qualifications, the Commission, although the student meets the minimum requirements for enrolment, deems it necessary to examine in greater depth certain subject areas characterising the master's degree course, it shall indicate to the student the appropriate methods to effectively make up any gaps in knowledge.
- 10. Verifying whether candidates have adequate personal preparation takes place: a) by enrolling on an "Assessment by qualifications", consisting of an in-depth analysis of the student's educational career, which takes into account the proportion of credits in the various scientific disciplinary sectors, of the teaching programmes, of the evaluations reported in the exams, and of past didactic experiences, etc.; b) on the basis of a possible in-depth interview, even remotely via videoconference, which the Commission reserves the right to organise if deemed necessary. A specially appointed Commission is responsible for ascertaining students' eligibility for enrolment (see clause 8).
- 11. Students in possession of the curricular requirements referred to in the preceding paragraphs and who have obtained a degree mark of not less than 90/110 are automatically considered to possess adequate personal preparation. Students with a final degree mark of less than 90/110 must undergo the assessment of personal preparation according to the procedures described in paragraph 10.
- 12. In order to allow access to other highly trained graduates from courses not perfectly consistent with the required requirements, a different entry path and/or specific admission test may be envisaged.
- 13. Students may enrol after the start of the academic year provided that there is enough time to allow the training activities to be attended, consistent with the general structure of the Master's degree course. The deadline for enrolment is, however, established each year by the University.
- 14. Non-EU students are also required to have a B2 level of Italian. More information at this link: https://portale.unipv.it/it/didattica/corsi-di-laurea/ammissioni/iscriversi-ad-un-corso-di-studio-contitolo-conseguito-allestero

Art. 7 – Organisation of educational activities

- 1. In accordance with current legislation, training activities that are part of the course of study result in the acquisition, by the students who take them, of university training credits (ECTS).
- 2. The average amount of overall learning carried out in a year by a student enrolled in full-time university studies is conventionally set at 60 ECTS.
- 3. Each ECTS awarded in the course of study is equivalent to 25 hours of average commitment per student, of which at least 50% is reserved to personal study or other individual training activities. In particular, 1 ECTS is acquired by following lectures, or equivalent teaching activities, for about 7 hours and dedicating about 18 hours to individual study (a course of 3 ECTS therefore corresponds to 20

hours of frontal teaching and 55 hours of individual study; teaching of 6 ECTS corresponds to 40 hours of frontal teaching and 110 hours of individual study, a course of 9 credits corresponds to 60 hours of frontal teaching and 165 hours of individual study).

- 4. Students acquire credits corresponding to each training activity by passing exams or following another form of verification of the preparation or skills acquired.
- 5. For some of the teachings offered, such as the courses on soft skills and on Sustainable Development Goals SDG), as defined by the 2030 Agenda for Sustainable Development of the United Nations, by passing the exam, in addition to the credits, the student can earn an open badge, i.e., a digital certificate as a proof of the knowledge, competency and abilities gained during the course. The certificate will be issued automatically after the registration of the exam and will be sent to the student's University of Pavia email address.
- 6. The credits acquired are not considered subject to obsolescence during the student's career, regardless of its duration, except in cases of loss of the student status or voluntary withdrawal from studies. In such cases, upon re-enrollment, the validation of previously acquired credits is subject, among other factors, to an evaluation of their possible obsolescence by the Department Committee nominated by the Department Council (see Article 16 below). In well-justified specific cases, the Committee may declare the obsolescence of credits related to specific learning activities. The resolution of obsolescence contains the indication of the modalities for the recovery of obsolete credits, specifying the possible supplementary tests that the student must take for this purpose.
- 7. The teaching activities take place according to the timetable approved annually by the Administration Board, on the proposal of the Academic Senate. The ordinary period for holding lectures, practical sessions, seminars and supplementary activities is usually established for each academic year between 1 October and the following 30 May. Frontal teaching activities are structured into semesters (October- December and March-May). Each semester normally includes 10 weeks of lessons. The lesson timetables are published on the Department's official website within the deadlines established annually by the Ministry for filling in the SUA form and, in any case, by June 30 for the first semester of lessons and by September 30 for the second semester.
- 8. Exam dates, set in periods when classes are not held, follow a schedule published on the Department's website within the deadlines set annually by the Ministry for the completing of the SUA form, and are uploaded to the platform for on-line registration at least two months before the relative examination session. There are 3 ordinary exam sessions, each with at least two exam dates for each course, and an extraordinary session (reserved for students who have not yet passed their exams). For all courses there are 7 examination dates for each academic year, organized as follows: in January-February, three exam dates for first-semester courses and two examination dates for other courses; in June-July, three examination dates for second-semester courses and two examination dates for other courses; in September two exam dates for each course; An extraordinary examination session open to students who have not yet passed their exams is held around March-April. The interval between two successive examination dates cannot normally be less than two weeks.
- 9. There are 5 annual sessions for the final exam. Dates and times of graduation sessions are published on the Department's official website by the deadlines set annually by the Ministry for completing the SUA form. For further details on the final examinations, please refer to art. 14 of these regulations.
- 10. Graduating students in the December and April sessions who owe only one examination may request an individual examination appeal in order to complete their career in time to comply with the procedures established by the office UOC Carriere Studenti within the deadlines. Information on how to request and conduct individual examination session is available on the Department's website.

Art. 8 – Study plans

- 1. All students are required to submit a study plan to the competent offices by the deadline date indicated annually by the University in the Academic Calendar.
- 2. A study plan is the set of accredited university and, possibly, extra-university activities that the student is required to carry out in order to acquire the training credits necessary for obtaining a

degree.

- 3. Study plans include compulsory activities, any optional educational activities and activities chosen independently by the student.
- 4. There are two forms of study plan: "standard" and "individual".
- 5. The standard study plan is approved annually by the Department Board and, when presented by the student, it is considered approved *ex officio*, provided that the educational activities independently chosen by the student meet the requirements established in article 11, paragraph 3.
- 6. For the reference cohort, the standard study plan is set out in **Attachment n. 1**, which constitutes an integral part of these Regulations.
- 7. Students who intend to follow a training path other than that envisaged **Attachment n. 1** may submit, in compliance with the constraints envisaged by the degree class declaration and by the didactic organisation of the course and resulting in a number of ECTS not inferior to that required for the award of the degree.
- 8. The individual study plan must be approved by the Department Board which, consulting with the member of the teaching staff heading the Master's degree and, taking into account the student's cultural training and professional preparation, may suggest changes be made in order to bring the training path in line with the specific training objectives of the course of study.
- 9. With reference to the teaching of foreign languages other than English, courses of the same level already taken during the three-year degree cannot be included in the study plan as part of the "Further linguistic choices". Specifically, only students who have achieved no more than 5 ECTS in the relevant scientific-disciplinary sector will be able to enter level 1 courses. Similarly, only students who have earned no more than 10 ECTS in the relevant scientific-disciplinary sector will be able to enter level 2 courses

Art. 9 – Double degree programmes

- As a result of a cooperation agreement between the Department of Political and Social Sciences of the University of Pavia and the University of Tirana (Albania), a double degree program has been established, allowing selected students from both institutions to obtain a double Master's degree in Economic Development and International Relations in Italy and in Economic Development and International Relations in Albania, based on the specific Study Plan attached to the Agreement.
- 2. Any new agreement, entered into after the approval of these regulations, shall in any case be valid for the relevant cohort.
- 3. The selection of the students admitted to the double degree programmes, the criteria and procedures for their enrolment, the financial conditions, the grade conversion system, as well as any other related or connected issue, are regulated, even in derogation from the present Regulations, by specific bilateral Agreements; specific information is made available in the calls for applications.

Art. 10 – Compulsory attendance and preparatory courses

- 1. Students have the right/duty to attend lectures and to actively and critically participate in all the educational activities envisaged by the Master's degree course.
- 2. For certain didactic activities, methods of ascertaining attendance may be planned, without prejudicing the right of non-attending students to carry out their individual preparation for the exam on the basis of a specific study programme.
- 3. There are no prerequisites between the courses.

Art. 11 – Students' elective choice activities

- 1. 12 elective choice ECTS may be inserted into the study plan (pursuant to art. 10 paragraph 5.a Ministerial Decree 270/2004 c.d. TAF "D").
- 2. Students may choose from university courses with the exception of those necessary for the

- achievement of the Bachelor's degree taken during previous university attendance.
- 3. It is possible to include in the study plan, among the electives, learning activities belonging to the teaching offer, except for the medical area courses of nationally restricted access and the psychology area courses.
- 4. In addition to the courses necessary for the graduation, it is possible to include a maximum of 24 ECTS of extra teachings to the study plan. The extra teachings can be selected from the bachelor's and master's degree courses offered, except for the medical area courses of nationally restricted access and the psychology area courses, and it is important to respect possible propaedeutics of the course.

Art. 12 – Internships and work placements

- 1. As part of the Erasmus Traineeship programme, internships at European institutions or companies may be recognised. At students' request, activities carried out may be accredited, as part of the study plan, up to a maximum of 12 ECTS as elective choice training activities (TAF D). In order for such credits to be recognised, students are required to write a report (of approximately 6000 characters) in which the activities carried out and the skills learned are illustrated and the organisational context in which the student was part of is analysed. This report is assessed for suitability by an internal tutor, that is a full professor from the Department assigned to the student at the beginning of the internship or placement.
- If consistent with the aims of the Masters degree course, up to a maximum of 12 ECTS may be included in the study plan as an elective choice activity: a) work orientation internships carried out on a voluntary basis; b) other professionalising and training activities aimed at facilitating professional choices and acquiring knowledge useful for entering the world of work.
- 3. For the recognition of the activities referred to in paragraph 2, students are required to submit a specific request. For recognition purposes, the aforementioned activities must be agreed in advance with the teacher in charge of the course.
- 4. With reference to the activities referred to in paragraph 2, 1 ECTS is considered to correspond to 25 hours of the student's overall commitment. If the hours employed in carrying out these activities are lower than those established for the corresponding credits, the student must draft a report (of about 5000 words) in order to complement the activities using curricular conceptual and methodological tools; this report will be assessed for suitability by the internal tutor, a full professor from the Department, assigned to the student at the beginning of the internship or placement.
- 5. The maximum number of ECTS that may be assigned for the activities cited in paragraphs 1 and 2 is 12 ECTS.

Art. 13 - Exams and final mark

- 1. The Master's degree course cannot include more than 12 exams or final marks.
- 2. The counting of the exams or final marks includes the comprehensive, additional, or elective educational activities chosen by the student. The final exams or final marks related to the latter activities count as one unit (even if the credits assigned entail several exams or final marks). The remaining educational activities foreseen in the study plan do not count toward the maximum ceiling of exams or final marks; the tests provided for these activities must not exceed 5, including the final exam for obtaining the degree.
- 3. Integrated tests may be envisaged for multiple coordinated courses. For such tests, students' work is assessed collectively by the course lecturers but the course cannot be divided into separate assessments of individual courses. If an integrated exam is required, all courses must be entered onto the student's study plan.
- 4. The exams are given in oral and / or written form or a combination of the two. The exams involve an evaluation expressed in thirtieths and reported in a special register. The academic credits are

awarded if the evaluation is equal to or greater than 18/30. In case of a maximum evaluation of 30/30, *cum laude* can be added to the mark. Based on the art. 30, paragraph 1 of the Students' Careers Regulation, it is necessary to register the evaluation of the exam even when it is negative.

- 5. Students may not repeat an exam that has already been passed and registered.
- 6. Students cannot take more than two exams during the same exam session.
- 7. Some educational activities (internships, Erasmus Traineeship etc.) will not have a final exam and/or mark but an evaluation based on completing the activities set.
- 8. Learning assessments and the related registering of marks are carried out by the lead teacher for the educational activity or, in his/her absence, by another professor from the University belonging to or attributable to the same scientific-disciplinary sector or to similar sectors and appointed by the Department Director. The lead teacher of the educational activity may form part of a commission.
- 9. The examination commissions are appointed by the Department Director in accordance with the provisions of the University Didactic Regulations.
- 10. For written assessment tests, students are required to know and respect the rules adopted by the Department regarding plagiarism.

Art. 14 - Final exam and awarding of the degree

- 1. The degree is awarded after passing a final exam, which verifies the achievement of the educational objectives of the course of study. The final examination, to which 24 credits are awarded, consists of the preparation and discussion by the student of a thesis based on original research, under the guidance of a supervisor assisted by a co-supervisor. The supervisor must be a faculty member of the University of Pavia. The co-supervisor (who may also be external to the University of Pavia) is appointed by the supervisor, who shall inform the Degree Program Coordinator, the student, and the Teaching Office of the selection. The "Procedure for Master's Degree" is available on the Department website.
- 2. The thesis is discussed in Italian or English but may be written in one of the following foreign languages: French, Spanish or German. In this case, the following requirements must be met:
 - the supervisor's authorization;
 - that an 'abstract' in Italian summarising the content be included to the thesis;
 - that the title be written in the double language, foreign and Italian;
- 3. Please consult the "General regulations on the norms concerning the writing of a degree thesis", published on the Department's didactics website.
- 4. The degree mark (ranging from a minimum of 66 points to a maximum of 110, with possible honours attributed for the high value of the thesis and conferred unanimously) is assigned, with collegial evaluation, by a specific Commission in public session. The marks take into account both the quality of the final exam and the student's overall course of study.
- 5. The methods for assigning the degree mark are: a) a calculation of the simple arithmetic average of the exam marks (the exam with the highest grade and the exam with the lowest grade are excluded from the calculation), reported out of 110; b) an assignment from 0 to 7 points made by the commission and based on the evaluation on the final exam. The possible awarding of honours, in addition to the maximum grade, is subject to the unanimous decision of the Committee.
- 6. The Department Director appoints the commissions for the awarding of degrees. These are composed of at least five members, of which at least four must be full professors or researchers who are responsible for teaching on courses for which the Department is responsible. The effective members should, preferably, include the degree thesis supervisors.
- 7. It is students' duty to strictly comply with the rules governing intellectual property. Without prejudice to any further legal sanctions, plagiarism is condemned by the academic community. Plagiarism is intended, pursuant to the provisions of art. 14 of the Code of Ethics, such as the partial or total attribution to oneself or to another author of words, ideas, discoveries, research results, or

as failing to cite sources. Plagiarism - whether intentional or as a result of non-diligent conduct - leads to disciplinary sanctions being applied. The lead teacher or individual teachers must report, in writing, to the Vice-Chancellor any violation of the rules relating to plagiarism. Disciplinary jurisdiction is exercised in accordance with the Student Career Regulations.

PART THREE – PROVISIONS RELATED TO THE STUDENTS' ACADEMIC CAREER

Art. 15 – Criteria for the recognition of duly certified extra-scholastic knowledge and skills

- 1. The following can be recognised as educational credits: a) knowledge and professional skills certified in accordance with current legislation on the subject; b) other knowledge and skills gained in post-secondary level educational activities in which a university has contributed to the design and implementation.
- 2. Pursuant to Art. 2 of D.I No. 931 of 4 July 2024, the maximum number of credits recognizable for both of the above types is in total equal to 24.
- 3. This recognition, approved by the Department Board after consulting with the lead teacher, is carried out exclusively on the basis of students' individual knowledge and skills, excluding any form of collective recognition.
- 4. The Department Board may recognise, up to a maximum of 6 ECTS, participation in sports certified by the competent authority, in the following ways:
 - sport practised at the Olympic, world, and European level, up to a maximum of 6 ECTS;
 - sport practised at the national level in Italy and intermediate categories, up to a maximum 3 ECTS;
 - activities for which a medal was awarded at the University Championships as well as the performance of competitive activities for CUS Pavia sections, also as regards competitions at the regional and national levels, up to a maximum of 6 ECTS.

Student-athletes of a high level are also given the opportunity to agree *ad hoc* exam sessions with teaching staff in the event of concomitant sporting commitments (competitions, training and relative travel).

Art. 16 - Criteria for the recognition of acquired credits

- 1. The Evaluation Commission considers the minimum curricular requirements (see article 6, paragraph 9) makes decisions regarding students' previous university career (second degree awarded abroad, career ended due to forfeiture or withdrawal, transfer from another university, change of course) of students who, upon enrolment, apply for the course to be abbreviated. An abbreviation may be granted after the evaluation and validation of the ECTS considered recognisable regarding the master's degree course.
- 2. The Evaluation Commission decides on students' possible admission to the second year of the master's degree course for those who have achieved at least 20 ECTS by passing courses in disciplinary sectors provided for in the first year.
- 3. In cases in which a student presents a validation request after the evaluation of curricular requirements stage, the Department Board for the evaluation of student files decides, on the proposal of the professor delegated by the Director, on the recognition of credits in cases of transfer from another university, from another degree course, on the carrying out of certain educational activities at another Italian or foreign university, or of students' previous career if they have already obtained a degree at the University or at another Italian university.
- 4. The validation of credits is decided by the Departement Commission on a case-by-case basis. The type of training activity (TAF) to which the credits are assigned and their number, within the legal limits where applicable, are determined based on disciplinary relevance criteria, considering the contribution of the training activity to achieving the learning objectives of the Master's degree

program, its specific content and possible obsolescence, as well as the required time commitment. To this end, the recognition request must be accompanied by all official documentation from which the aforementioned elements can be verified; the Commission may carry out additional checks if deemed necessary.

- 5. If students have transferred or switched between degree programmes of the same class, the share of educational credits, relating to the same scientific-disciplinary sector, directly recognised cannot be less than 50% of those already accrued.
- 6. Students who transfer from another degree course or from another university will have exams recognised with the credits attributed to the courses activated in the master's degree course. If an exam taken on another degree course or at the university of origin awards a lower number of ECTS, the student is required to integrate it until the necessary credits are reached.

Art. 17 – Criteria for the recognition of educational activities undertaken while studying at a foreign or Italian university

- 1. Students enrolled in this Master's Degree may carry out part of their studies at universities in Italy or abroad with which conventions or agreements (Erasmus programs, or other exchange programs) have been stipulated.
- 2. Study periods abroad normally have a duration ranging between 3 and 10 months extendable, where necessary, up to a maximum of 12 months. Study periods at other affiliated Italian universities have a minimum duration of 3 months up to a maximum of 6 months. The study plan to be carried out at the host university, valid for university career purposes, and the number of credits that can be acquired must be appropriate to the duration.
- 3. Opportunities for studying abroad or at other Italian universities are communicated to students through specific calls for applications, which include, among other things, the eligibility requirements and selection criteria. Selected students may be granted financial support or other benefits provided by mobility programs and exchange agreements. A mobility grant is generally awarded in the case of exchanges carried out within the framework of the EU Erasmus Program or in the case of the Italian Erasmus national mobility program (the relevant conditions are specified in the respective call).
- 4. During the mobility period, the student may carry out the following activities, in accordance with the provisions of the relevant calls for applications:
 - a) attend courses and take the corresponding exams;
 - b) conduct research activities in preparation for the thesis.
- 5. In the definition of the learning project, the student, in agreement with the Erasmus Delegate, must indicate the activities they intend to undertake abroad (or at the agreed Italian university in the case of Italian Erasmus) and which correspond to those in their study plan. Before leaving, the student must present the learning agreement (document containing the list of courses to be taken during the mobility period with the corresponding credits), which must be agreed and signed by the student, the Erasmus delegate for the course of study and the correspondent at the host university. Up to a maximum of 18 credits may be awarded, within the 24 CFU provided for the Master's thesis, for research work carried out during the mobility period.
- 6. At the end of the study period, on the basis of the "Transcript of records" (issued by the foreign or Italian host university), the Departement Committee decides on the recognition of the examinations taken abroad or at the Italian host university (if pertinent to the educational pathway), awarding the relevant CFUs.
- 7. The University of Pavia guarantees full recognition of the educational activities carried out during the mobility period if they comply with the most recent approved learning agreement.
- 8. If the recognised educational activities are not included in the student's last approved study plan, the student must revise the study plan according to the indications provided by the Department

Board.

9. Students who have completed a mobility period and request validation of the activities undertaken abroad or at another affiliated university will not be admitted to the degree program final exam without a formal validation approval.

Art. 18 – Admission to successive years

1. There are no conditions that affect registration in subsequent years.

Art. 19 - Certifications

1. International certifications attesting to students' language skills can be taken into consideration by language course teachers in order to reduce the exam programme.
