PART ONE – GENERAL REGULATIONS

Art. 1 – Name, class, location, and length of degree programme

1. The second-cycle degree in English in *Psychology, Neuroscience and Human Sciences* at the Department of the Science of the Nervous System and of Behaviour at the University of Pavia is carried out in collaboration with the *Scuola Universitaria Superiore* IUSS Pavia (School for Advanced Studies). It belongs to Class LM-51 of the second-cycle degrees in Psychology as indicated in ministerial decree (DM) 16 of March 2007 and DM n. 1649 of 19 December 2023.
2. The second-cycle degree lasts two years.

Art. 2 – Regulatory texts of reference

To ensure the freedom of teaching and the rights-duties of teachers and students, the organization of courses and the carrying out of academic activities for the interfaculty second-cycle degree in *Psychology, Neuroscience and Human Sciences* are regulated by the present Regulations, in conformity with the convention of collaboration between the University of Pavia and the IUSS regarding the creation, activation, organization and management of the degree programme, with the statute of the University of Pavia, with the general university regulations (which can be found at:

Anything not expressly indicated in the present Regulations comes under the existing legal provisions.

Art. 3 – Body responsible for course and organizational coordination

In compliance with the criteria established by the Regulations in Article 2 and the Regulations for the composition and functioning of the didactic councils, the body responsible for course and organizational coordination is the didactic council for *Psychology, Neuroscience and Human Sciences*, henceforth indicated as the Didactic Council. The Didactic Council determines the faculty member of reference for the degree programme, who is indicated by name in the SUA form (*Scheda Unica Annuale* - Annual Study Plan) (<https://gestionedidattica.unipv.it/index.php/file/2025SUA05432.pdf>). The Didactic Council is composed of all faculty teaching in the degree programme as well as a student representatives. It annually appoints a commission to select and evaluate candidates applying for admission, deciding on any recognition of previous academic activities and, if necessary, on ways for foreign students to make up for any gaps in their academic preparation when there is allowance for greater flexibility in their academic curriculum.

Each year, the Didactic Council determines the curriculum and activates the *Practice Courses and Labs*, PCL) to offer a complete curriculum for the various subject areas, to coordinate the various courses across several semesters, and to sequentially arrange any prerequisite courses that may be necessary.

Art. 4 – Administrative services

The Student Secretariats (divided into: U.O.C. Enrollment Procedures and Information Students Office, Admission Office, Student Career Management Office) deal with the administrative management of the student's career, from the moment of his entry to the University until graduation (enrollments, transfers, fees, recognition of qualifications, student mobility, etc.). The offices of the Student Secretariat are located in Via S. Agostino 1, Pavia and via Ferrata, Pavia.

Art. 5 – Annual Study Programme of the course of study

Art. 6 – Admission requirements

1. The second-cycle degree has a closed number of admissions. In accordance with Article 2, clause 1, letter a) of Law 264/1999, each year the academic authorities determine, based on the proposals of the Didactic Council and the decisions of the Departmental Board for the Science of the Nervous System and of Behaviour, the quotas for admission (which also include the number of foreign extra-community students not regularly resident in Italy to be accepted into the degree programme) and also create a commission to evaluate the candidates previous degrees for purposes of admission, as defined in clause 4 below.
2. To gain admission into the degree programme, the student must possess a three-year university degree or diploma, or another degree or diploma from an Italian or foreign institution deemed suitable by the competent university bodies (cf. Student Regulations).
3. Admission entails a selection process based on previous degrees or diplomas and a possible interview.
4. The selection of students will consider both the eligibility criteria for second-cycle degrees in Psychology (88 credits in at least 7 psychology SSDs (Scientific Disciplinary Sectors) from M-PSI/01 to M-PSI/08) and *ad hoc* evaluations for foreign students in order to equate their academic preparation with that required for Italian students. Students with a degree from a foreign university can be evaluated in terms of the equivalence of their degree with the three-year degree in Psychology Science and Techniques (L-24) rather than the 88-credit requirement and/or possession of the Europsy certification. In such cases, the commission may also require specific tutoring activities to ensure uniformity between the academic background of foreign students and those from Italian universities.
5. To gain admittance to the second-cycle degree programme, students must present during enrolment a suitable language certificate (see recognized certificates in Article 19) and demonstrate a minimum B2 level (Common European Framework of Reference for languages – CEFR) in both written and spoken English.
6. Students not possessing such a language certification or to whom clause 4 above applies can have their language competence verified during the selection exam.
7. The recognition of the 10 ECTS of TPV (Applied Practical Activities) that can be carried out within the three-year degree may possibly be evaluated as equivalent also in the case of activities carried out within foreign degree courses. In the absence of total or partial recognition of the 10 ECTS of the TPV, the student will be able to acquire the aforementioned missing credits during the two-year period, as supernumerary compared to the 120 ECTS of the master's degree.
8. The enrolment procedure and participation in the selection process, as well as the publishing of the selection ranking and enrolment lists, including replacement students and reduced credit requirements, are published in the “Call for applicants” on the Student Affairs webpage: <https://portale.unipv.it/it/didattica/corsi-di-laurea/corsi-di-laurea-magistrale/psychology-neuroscience-and-human-sciences> - “How to enroll”.

Art. 7 – Course organization

1. Each credit corresponds to 25 hours of activity per student, as indicated in the regulations: 6 hours of lessons (or equivalent course activities) and 19 hours of individual study. By regulation, the average amount of learning activity by each full-time student in one year is 60 credits (CFU). Except for the circumstances described in Article 13, the credits corresponding to each academic activity of a student are earned by passing an exam or following another form of evaluation of his or her preparation or acquired competencies.
2. The lesson schedule is determined annually and entails a didactic activity normally from September to June, interspersed with exam sessions.
3. There are three exam sessions (during periods in which lessons are suspended): a winter session (January-February), a summer session (June-July), and a make-up session in September. In all, there are at least 6 exam dates: 2 during the winter session, 3 during the summer session, and 1 during the make-up session. By regulation, exam dates during the session must be scheduled at least two weeks apart.
4. The graduation sessions are by regulation scheduled in March, July and September.

5. The academic calendar of lessons, exams and thesis defense sessions are published on the website <https://psychology.cdl.unipv.it/en> .
6. Athlete students can ask for specific extraordinary exam sessions, after submission of certificates attesting the occurrence of sports events on exam dates. An athlete student is defined as a student practicing sport with at least one of the following requirements: athlete of national interest certified by the national sports team of reference; being admitted in one of the meit Collegi in Pavia (Collegio della Pagaia, Collegio Remiero, Collegio Sportivo), as set by article 8 of the students' career regulations.
7. For some of the teachings offered, such as the courses on soft skills and on Sustainable Development Goals – SDG), as defined by the 2030 Agenda for Sustainable Development of the United Nations, by passing the exam, in addition to the credits, the student can earn an open badge, i.e., a digital certificate as a proof of the knowledge, competency and abilities gained during the course. The certificate will be issued automatically after the registration of the exam and will be sent to the student's University of Pavia email address

Art. 8 – Study plans

1. The *standard course syllabus* is the set of academic activities (required, optional and freely chosen by the student), along with any prerequisite courses, which the student must undertake in order to obtain a degree. The standard course syllabus for the second-cycle degree includes the academic activities called for by the students (see ATTACHMENT 1). Study plans that conform to the standard model in the present Regulations are automatically approved.
2. Students who intend to follow a course of studies different from that called for in the present Regulations may present an *individual study plan* within the deadline established annually by the university.
3. The individual study plan may also include learning activities other than those foreseen by the teaching regulations, as long as they are consistent with the teaching system of the degree programme for the academic year of enrolment and as long as they result in the acquisition of a number of credits that is not less than the number required to obtain the qualification.
4. The individual study plan must be approved by the Didactic Council, which will consider the requirements for the students' educational and professional preparation. The Council may suggest appropriate changes to the study plan to make it more coherent with the educational objectives of the degree programme.
5. All students are required to present their study plan within the terms indicated annually by the university.

Art. 9 – Joint degree programme

There are provisions for programmes or agreements for the awarding of a joint degree.

Art. 10 – Attendance and course prerequisite requirements

1. There are normally no attendance requirements for courses. However, attendance is strongly recommended. Some courses may require obligatory attendance. Students not able to attend must arrange with the teacher the necessary additional activities.
2. Attendance is required for Applied Practical Activities (Tirocinio Pratico Valutativo) APA.
3. Normally there are no prerequisite courses when moving from one course to another. Any prerequisites for each discipline are indicated in the programmes of the individual courses published on the University of Pavia webpage in the "Course Catalogue".

Art. 11 – Student optional activities

1. The study plan for students enrolled in the second-cycle degree allows for 12 credits for elective courses (see Article 10, clause 5 of ministerial decree (DM) 270/2004 – the so-called "TAF D"). The Didactic Council proposes a list of recommended courses and activities, though the student has the right to choose whichever course the student prefers from among those offered and accredited at the University of Pavia, as long as the course is coherent with the educational project.
2. Among the elective activities (see Article 10, clause 5 of DM 270/2004 – the so-called "TAF D"), students may choose courses which are part of the limited-number courses of study, both at the local and national levels, except for limited-number courses at the national level in the medical area. Students may also include courses offered in first-cycle degree programmes.
3. Students may not choose courses already taken previously at university, unless they have obtained specific validation for these courses outside of the 180 credits needed to obtain a first-cycle degree.
4. Students may include each academic year in their annual study plan academic activities as additional exams, not exceeding 24 CFUs, including the training activities offered by LM courses, except for courses belonging to the medical and health areas of restricted-access programmes. It is advised to respect the possible propedeutic nature of the extra exams included in the study plan.

Art. 12 – Internships and apprenticeship

Within the course of study, 20 ECTS of professional training activities called "practical-evaluative internship" (hereinafter, TPV) are foreseen. These are contextualized and supervised practical activities, which involve direct observation and the execution of activities aimed at situated learning and the development of procedural and relational skills and abilities fundamental for the exercise of the professional activity. These skills refer to the typical and confidential acts characterizing the profession of psychologist and include the use of cognitive and intervention tools for prevention, diagnosis, habilitation-rehabilitation activities, support in the psychological field aimed at the person, the group, social organizations and communities, as well as experimentation, research and teaching activities. The TPV activities are carried out in operational contexts, for a minimum number of 14 ECTS, at qualified external bodies affiliated with universities, including public or private healthcare facilities accredited and contracted with the National Health Service.

Each ECTS reserved for the TPV corresponds to at least 20 hours of vocational training activities and no more than 5 hours of supervised in-depth study.

The student carries out the TPV under the supervision of a tutor (professional registered with the Order of Psychologists), who at the end of the internship evaluates the skills acquired by the student. The tutor, by filling in a booklet, issues a formal certificate of attendance, together with the assessment of the skills shown by the trainee and expresses the judgment of suitability/non-suitability. These skills refer to:

- a) the evaluation of the case;
- b) the appropriate use of psychological information-gathering tools and techniques to carry out case and context analysis;
- c) the preparation of a theoretically founded and evidence-based professional intervention;
- d) the evaluation of the process and outcome of the intervention;
- e) the drafting of a report;
- f) to return to patient/client/user/institution/organisation;
- g) establishing adequate relationships with patients/clients/users/institutions/organisations;
- h) establishing adequate relationships with colleagues;
- i) the understanding of the legal/ethical/deontological profiles of the profession, as well as their possible conflicts.

The TPV is passed by obtaining a judgment of suitability. Passing the TPV (and the consequent acquisition of the relative ECTS) allows admission to the practical assessment test (PPV) which is part of the final qualifying exam.

The student who obtains a negative evaluation of the internship activities repeats the TPV, or part of it. In this case, however, the recognition of the part of professional training activities possibly carried out during the course of study of class L-24 remains unaffected.

The PPV is accessed after having acquired, over the five-year period (three-year degree + master's degree) 30 ECTS of TPV (750 total hours), 10 ECTS of which are foreseen in the three-year course of class L-24.

For the purposes of enrollment in the master's degree course in Psychology - qualifying class LM-51, those who have graduated in class L-24 Psychological sciences and techniques based on the previous system and who have not carried out the corresponding professional training activities to the 10 ECTS referred to in the previous point, they can request recognition of activities carried out and certified during the three-year degree course, in relation to:

- a) activities, carried out individually or in small groups, aimed at learning methods, tools and procedures, related to the application contexts of psychology;
- b) practical experiences, laboratories, simulations, role playing, drafting of projects, carried out individually or in small groups, concerning tools, methods and procedures aimed at developing the knowledge necessary to operate in the contexts in which psychologists intervene.

In the total or partial absence of the recognition of the aforementioned ECTS, three-year graduates acquire the missing training ECTS in addition to the 120 ECTS of the master's degree.

The possibility of recognition of further orientation internships in the world of work is not excluded, i.e. extra-curricular internships carried out on a voluntary basis by students as long as they are compatible with the training path carried out. These internships can be recognized by the Academic Council, subject to the favorable opinion of the professor in charge of the study course:

- as an activity freely chosen by the student
- as an off-plan teaching activity (supernumerary)
- as part of the TPV (only if it has the same characteristics)

Activities performed in the frame of the Erasmus Traineeship programme (see article 17) can be validated:

- as elective activities selected by the student,
- as part of the TPV (in case the characteristics are similar),
- as CFUs useful to prepare the final thesis.

Art. 13 - Exams and final mark determination

1. Exams can be both oral and/or written, depending on the didactic requirements of the teachers on the course. The format of the exams is indicated as part of the teaching programme published on the University of Pavia website in the "Course Catalogue": (<https://unipv.coursecatalogue.cineca.it/>).

2. The marks for exams are out of 30. Credits are awarded for marks equal to or above 18/30. In the case of a maximum mark of 30/30, may be awarded *cum laude*. Students are not allowed to repeat an exam already passed in the attempt to getting a higher mark.

3. The assessment of student learning outcomes and the marks assignment are responsibility of the teacher of the course (or, in their absence, by a substitute teacher), who can work with a Teacher Evaluation Committee elected in accordance with the University Course Regulations.
4. During each exam session, a student can take all the exams (regarding courses already given in the academic year of enrolment) indicated in the study plan, and viewable in the reserved area of the university webpage, without any limitation, except for any prerequisites that may be required. To gain admittance to an exam, students must enroll online in their reserved area following the indications provided in the website: <https://web-en.unipv.it/info-for/study-and-exams/> - "Exams".
5. An adequate knowledge of the Italian language is required for all applicants. EU, equivalent and non-EU students with qualifications obtained abroad will be required to follow an Italian course for foreigners as part of further linguistic knowledge. Students shall be considered exempt if they: (1) have obtained a high school or university degree in the Italian language in Italy; (2) have obtained an Italian school degree abroad, (3) hold a B1 Level Italian language certificate or, alternatively, prove they have a B1 Level-like knowledge of the Italian language.

Art. 14 – Final exam and awarding of degree

1. The qualification is awarded after passing a final test, which will tend to verify the achievement of the educational objectives of the master's degree course in Psychology, neuroscience and human sciences. The final test has the value of a state exam enabling the practice of the professional activity of psychologist (L. 8 November 2021, n. 163, articles 1 and 3).
2. The final exam consists of two parts:
 - 1) a Practical Evaluation Test (PPV) of the professional skills acquired with the internship within the study programmes, aimed at ascertaining the level of technical preparation of the candidate for the qualification to practice the profession. The Practical Evaluation Test, carried out in oral mode, focuses on the activity carried out during the TPV and on the links between theories/models and professional practices, as well as on aspects of legislation and professional ethics. The PPV is aimed at ascertaining: a) the candidate's ability to critically reflect on the overall internship experience and the activities carried out, also in light of the aspects of legislation and professional ethics, demonstrating that he is able to adopt a professional approach based on theoretical and evidence based models; b) the candidate's ability to highlight the links between theories/models and the practice carried out during the internship; c) the candidate's knowledge of the code of ethics for psychologists.
The Commission of evaluation of the PPV, is composed equally by at least 4 members: for the half, university professors one of which with function of President, designated by the Department to which the course pertains, and, for the other half, members designated by the National Council of the Order of Psychologists, enrolled for at least five years in the relevant professional register. The PPV is considered passed with the achievement by the student of the assessment of suitability. Admitted to the test are those who obtain a judgment of suitability of the Practical-Evaluative Internship (TPV) within the study courses (internship of a total of 30 ECTS acquired during the five-year period);
 - 2) preparation by the student of a thesis, elaborated in an original way under the guidance of a supervisor (usually identified by the beginning of the last year of study), and his dissertation before a specific selection commission. Students who have obtained the judgment of suitability in the Evaluation Practice Test (PPV) are admitted to the discussion of the thesis. The test is public.
- 3) The overall mark, expressed out of one hundred and ten with honors, if any, is given by the sum of the score obtained from the weighted average of the marks achieved in the course of study (excluding supernumerary exams), added to the evaluation attributed to the final report, on the basis of the type and the quality of the work, the judgment of the supervisor and co-supervisor, the presentation made by the graduating student and the subsequent discussion. The attribution of honors is subject to the unanimity of the Commission of selection.
- 4) The thesis must be written in English. The final exam is held in English.

PART Three – Regulations regarding students' academic standing

Art. 15 – Criteria for the recognition of duly certified extra-university knowledge and skills

The Didactic Council, (following a request by a student and after deliberations that take into account the view of the teacher of reference) can validate up to a maximum of 24 credits (overall for two-year period, taking into account the limit of 48 credits on the entire academic career), in accordance with Article 3 of DM 931, 4 July 2024:

- a) professional knowledge and skills duly certified in each case in according with existing regulations as well as other skills and knowledge acquired in training activities at post-secondary level.
- b) training activities performed in training centres of public administration, as well as other skills and

knowledge acquired during training activities belonging to the post-graduate level, for which the university took part in creating and planning;

c) obtaining an Olympic or paraolympic medal by an athlete student, or the title of world champion, European champion or Italian champion in disciplines recognized by the national Olympic committee or the Italian paraolympic committee.

Recognition is granted exclusively based on the competencies shown by each student; therefore, the Didactic Council will evaluate on a case-by-case basis whether to interview the student to verify, before an appropriate commission, whether the credits for which validation is requested match the knowledge and skills actually possessed.

With reference to point c), the Teaching Board may, for a maximum of 12 credits, validate engagement in sports activities certified by the relevant authorities, under the following terms:

- Engaging in sport at an Olympic, World and European level: up to 6 credits;
- Engaging in sport at a national and intermediate category level: up to 3 credits;
- Ranking in top positions at the University Championships as well as engaging in competitive activities for the sections of Pavia University Sports Centre, including as part of competitions at a regional and national level: up to 6 credits.

Top-level students/athletes shall also be given the possibility of agreeing ad hoc exam sessions with their teachers in the event of concurrent sports commitments (competitions, training and related travel).

Art. 16 – Criteria for the recognition of credits earned

1. The Didactic Council, following a request by a student (according to the procedure and time frame set by the university), and after an examination of the relative documentation, will decide on the recognition (type and number of educational activities) of the earned credits:

a) in cases of transfer from another university, from one course of study to another, or the undertaking of educational activities in another Italian or foreign university;

b) in cases of transfer from one course of study to another in the same class (in this case, the share of credits for the same scientific-disciplinary sector that are directly awarded to a student cannot be below 50% of those actually earned);

c) in cases of a student who has already received his or her degree from the University of Pavia or another Italian or foreign university and who requests at the time of enrolment an abbreviated degree programme;

d) when a student has earned credits in excess (with respect to the 180 required for obtaining a degree) for the first-level degree programme (at the University of Pavia or another Italian or foreign university).

2. Based on the number of credits granted, the Didactic Council can decide to abbreviate the degree programme. In all cases presented in clause 1, the student must in any event take part in the obligatory selection process.

3. Academic degrees earned at foreign universities can be deemed equivalent to the corresponding ones from the University of Pavia based on specific arrangements in international conventions. In the absence of such conventions, the University does not accept requests for academic recognition for this course.

4. There is no expiration date for credits earned during previous courses of study. The credits so acquired by individuals who no longer have official student status (because they have abandoned their studies or have not taken exams for the number of consecutive years required by existing regulations for the course of study in question) can be validated by a decision of the Didactic Council that the educational content involved is not obsolete.

Art. 17 – Criteria for the recognition of academic activities at foreign or Italian universities

1. Students in degree programmes may undertake part of their studies at foreign or Italian universities where agreements or arrangements are in place (Erasmus programme or other exchange programmes).

2. During his or her study abroad, students can take courses and exams, even activities to prepare their dissertations, in accordance with the dispositions reported in the dedicated calls.

3. In defining an educational plan, students, in agreement with the teachers of the discipline in question, must indicate the activities they intend to undertake abroad, or at the Italian university set by the arrangement in case of the Italian Erasmus project; these activities must correspond to those indicated in the study plan. Before leaving for the mobility, students must present the *learning agreement* (a document listing the courses that will be taken and the corresponding credits), which must be agreed upon and signed by the student, delegate for international mobility in the area, and the corresponding figure at the host university.

4. At the end of the period of study, the Didactic Council, based on certificate of the course activities abroad in the “*Transcript of records*” (issued by the host university), will decide about the recognition of exams taken during the mobility period (if relevant to the study plan in question) and award the relative credits.

5. The University of Pavia guarantees full recognition of educational activities undertaken during the mobility if these conform to the most recently approved *learning agreement*. Teaching activities performed abroad cannot be recognized if not present in the *learning agreement*, as approved before leaving or following the agreed modifications.

6. If the recognized educational activities are not included in the most recent study plan approved for the student, then the student must change the study plan following the indications of the Didactic Council.

7. Students' activities during the *Erasmus Traineeship* programme (previously named *Erasmus Placement*) may be recognized by the Didactic Council (based on their pertinence to the study curriculum) (cf. Article 12).

Art. 18 – Admission to subsequent years

With reference to Article 6, clause 4, and Article 16, a student may be admitted to the second year if they earned 30 credits in the existing study plan for the second-cycle degree in *Psychology, Neuroscience and Human Sciences*, subject to approval of the Didactic Council.

Art. 19 – Certificates
